## Subcommittee meeting March 29, 2024

- Reviewed forecast model under varying scenarios (provided in handouts)
- Water infrastructure needs in New Hampshire and potential demand and priorities on funding
- Available funding from Federal Bipartisan
   Infrastructure Law
- Special Project Criteria





# **Finance Subcommittee Update**

## Spending Plan -2024

- ✓ Maintain the 20% balance allocation \$21.1 M
  - o 40% loan: \$8.4 m
  - 60% Grant: \$12.6 (\$2.0 M for SWP)
- ✓ Focus remaining \$9.6 M construction funds on Special Construction Projects in process
- ✓ Skip Annual Round
  - $\circ~$  DES fund projects with Federal BIL money first
- ✓ Tighten up the Special Project criteria
- ✓ Fund the Source Water Protection
   Program at \$2,000,000



# **Finance Subcommittee Update**

## Spending Plan -2025

- ✓ Maintain the 20% balance allocation
  - $\circ$  40% loan
  - 60% Grant: (10% for SWP grants)
- ✓ Skip Annual Round
  - $\circ~$  DES fund projects with Federal BIL money first
  - Subject to mid-term review by Advisory Commission
- ✓ Tighten up the Special Project criteria
- ✓ Fund the Source Water Protection Program at \$2,000,000

# Status of Drinking Water Construction Projects

**Currently 64 active projects** 

- 40 Projects are in design-phase
- 24 Projects are under construction
- Of the 16 projects approved for funding in 2023
  - 6 approved at G&C
  - 3 funding agreements routed for Governor and Council approval soon

KOMAT

- 5 waiting for final application materials- due May 1, 2024
- 2 have withdrawn (\$4,375,000 loan and \$100,000 grant)
- Projects recently completed and closed
  - No updates

2021 Funding TF Grant: \$25,000 TF Loan: \$25,000 ARPA: \$1,938,800 (\$1m drinking water)

**2024 SPA Request – Gap TF Grant:** \$75,000

Total Request TF Grant: \$75,000

**Total Project Cost** \$2,063,800

## SPECIAL PROJECT ASSISTANCE APPLICATION Town Line Village Cooperative, Inc.

- X Is there drinking water contamination? The project does not address immediate public health risks.
- Is the project time critical? Yes, the project is currently under construction and additional funds are needed to complete the scope of work.
- Is there financial hardship? MHI = \$27,500. In 2022 the Affordability Index was 1.5.
- X Does the project support economic growth? No, while the project will improve the economic wellbeing of the residents, it does not expand the water system to increase capacity for additional housing or new businesses.

## SPECIAL PROJECT ASSISTANCE APPLICATION Town Line Village Cooperative, Inc.

### **History of the System and Funding**

• 77-unit mobile home park

Significant deficiencies 53-year-old distribution system constructed without engineer oversight.

- Chronic leaks in distribution system, difficult to locate, some lines totally inaccessible.
- Two confined space pumphouses, a third in the basement of a rental home.
- Poorly constructed confined space to access meters, valves, tanks.
- Lacks isolation valves, curb stops, and blow off valves.

2021- Awarded \$25,000 grant and \$25,000 loan DWGTF and \$1,000,000 ARPA for water portion of project Water System Stats Household Income: \$27,500 Current User Rates: \$408 Current AI: 1.5 Connections: 70 Population Served: 105

## SPECIAL PROJECT ASSISTANCE APPLICATION Town Line Village Cooperative, Inc.

### **Project Scope and Funding Request**

Most of the project is completed

- Design and construction of a new pumphouse
- Replacement of entire distribution system
- Addition of curb stops at each service, isolation valves, flushing valves
- Electrical upgrades
- Decommission existing confined spaces and equipment
- Bids were higher than anticipated and additional funding required to complete the top-paving

### Funding Request: \$75,000 grant


51 water supply protection projects funded

-900 ac Wellhead Protection Areas

- 1,500 ac Hydrologic Area of Concern
- 170 ac High-Yield Stratified Drift Aquifers

### • 23 Active Projects

- 3 are in the process of final completion
- 9 have received Governor and Council approval and DES is working with grantee on closing and due diligence
- 14 are in process of G&C approval

## **Proposed Grant Round Timeline**

Preapplication May 30<sup>th</sup> Full Application August 8<sup>th</sup> Initial Subcommittee meeting Late August Site Visits and Subcommittee Final Review August-October Advisory Commission votes on funding November Funding Notification Letters

Early December



**Subcommittee Recommendation** 

Move to accept the proposed timeline for the 2024 Source Water Protection grant round and allocate \$2.0 million to fund eligible water supply land protection projects for the 2024 grant round.
